Vendor's License Permit Application

Vendors must obtain a license from the County before engaging in business. Itinerant Vendors engaging in business in the service area of Doña Ana County shall pay an annual license fee of thirty-five dollars (\$35.00). Temporary Site-Specific Vendors shall pay a license fee at the rate of five dollars (\$5.00) per day not to exceed twenty-five dollars (\$25.00) for the entire one hundred twenty (120) day maximum allowable period for each site. An application must be completed for each business.

 All display stands or structures must comply with any applicable County Building regulations. Vendors shall not obstruct any public road or right-of-way while engaging in business and be located in a commercially zoned area. A minimum twenty sq. ft. (20sq.ft) area is required for each display stand. 			
4. Each display must have at least one trash receptacle with a minimum height of three feet (3').			
5. All display signs must be placed in areas that do not obstruct traffic or the public view.			
6. Two (2) customer parking spaces must be provided for each display and one (1) space for every two			
hundred feet (200 sq.ft.) or portion thereof for the designated display area. Every vendor shall display the "Vendor's License" issued by the County Clerk's Office at all times.
